Devolved Regional Reports from December 2024

Scotland Report from Ainsleigh Brown (Transport Scotland)



Roadworks Reform and Related Legislation - Development of VAULT part two (what information is supplied and when) continues, while part one is now implemented (mandatory supply). We recently ran a live consultation aimed at the road worker experience of using plans. The analysis paper from the consultation should be published before the end of 2025. Happy to share this

with HAUC once published. Parallel with the consultation, there have been on-going discussions with the PDG and focus groups. to gain general views what is considered required for safe digging and what information is deemed useful for identification. There are some minor amending SSIs/Orders being progressed, which support earlier primary legislation. In terms of the road works community these will have no impact on day-to-day work but will be the short-term focus of the road works policy team.

Codes of Practice - The redrafting of the Diversionary Works Code continues. The code contains a large volume of outdated material, and we support taking as long as is needed to fully review the existing content, given the long period since last review. Bill Lees and John Oneil have joined the UK wide working group for Scotland's interests. We continue to be pleased to note appropriate Scottish involvement on both UK wide groups (Safety and Diversions), which builds confidence that the resulting draft will be fit for purpose in all four nations. The final approval of both Codes sits with respective Ministers

Scottish Government - The Cabinet Secretary for Finance and Local Government, Shona Robison, recently set out the Scottish Budget and draft spending and tax plans for 2025 to 2026. All policy areas within SG including road works will take this into consideration for future policy plans.

Wales Report from Gail Davies (South Wales Transport)



Safety code - things are still progressing in line with England. Diversionary work is currently ongoing, the group are liaising with experts from the utility industry to progress, with anticipation of completion next year. T & A , it has always been intention for Wales to follow suit, but with current considerations being given by other devolved nations, the decision has been made to wait to see what happens.

SROH - Working Group is now nearing completion of the first "run through" by consolidating the current Welsh / Scottish / English equivalents of the documents to meet the specific needs of Wales .

Network Occupancy: We are currently still in procurement stage, with completion expected April 2025.

Northern Ireland Report from Nile Smith (NI Infrastructure)



NIRAUC: Department for Infrastructure NI (Dfl) attended NIRAUC meeting in September and December 2024 with the next meeting scheduled for March 2025. We continued to hold quarterly SWAG (internal Dfl group) and divisional DRAUC (Dfl authority / utilities group) meetings. These meetings continue to facilitate co-ordination and communication on Street Works issues.

Performance Monitoring: Dfl continued its programme of monitoring and reporting Key Performance Indicators based on coring / testing and data from the NISRANS noticing system.

NIAO: the report has now been published and is available at NI Audit Office Report - Road Openings by Utilities.pdf

Working Groups: Due to staff changes and constraints on staff resources it has not been possible to attend any HAUC working groups.

NUAR: DfI has continued to engage with Geospatial Commission in sharing data on underground assets. Following the change of UK Government a fresh discussion on the draft Data (Access and Use) Bill is taking place and how this could lead to amendments to the Street Works (NI) Order 1995.

England Report from Peter Loft (Co-Chair HAUC England)



Street Manager: Meetings of the Governance Group and SME's continue. There were a number of DfT sponsored Webinars/F2F meetings in the year which were welcomed by practitioners in terms of better understanding.

Recent SM release in respect of non-compliance management is proving a challenge for practitioners in terms of system interfaces and consistency of status for both HA's and SU's.

Inspections CoP The HAUC Eng Insp's Operational Guidance document has been completed and is currently with the Department before issue to the Sector. As well as providing consistent operational guidance to all practitioners the document contains a FAQ section following recent queries raised. Liaison with the SM Project Team continues to ensure consistent advice and deliverability.

DfT Stat Guidance for Permit Schemes and National Conditions As a result of feedback from practitioners regarding the above a Joint Working Group has drafted a HAUC Eng Permit Scheme Operational Guidance document which is currently with the DfT for consideration and to ensure consistency, before circulation. In addition, the sterling efforts by the Joint SE/SW and London HAUC's Conditions Guidance document Team has resulted in first "train the trainer" sessions in the SW.

DfT Consultations and Lane Rental. Ministers and the Dept Officers have been briefed to encourage further, more widespread application of Lane Rental Schemes. The Dept is currently considering how deployment can be expedited. Officers have reviewed the views/comments/outputs etc. from the earlier consultations but currently there is no clear list of priorities for these matters.

Road closures: Workers facing knives, machetes and guns - BBC News

Road workers face abuse



Highway workers still facing abuse with road work incursions on the rise.

There are calls from across the industry to crackdown on abuse from members of the public, following figures

highlighted by the BBC in a recent article, that show 541 cases of abuse towards highway workers were recorded by National Highways between 2020 and 2023. A number of undertakers, contractors, traffic management companies and local authorities are backing the Stamp It Out Campaign which is calling for a simpler incident reporting system and more public education.

The campaign group says more than 2,000 reports of

abuse towards staff were recorded in 2023.

The number of incursions into road closures is also on the increase. Figures released by National Highways suggest over 7,200 reports of incursions in the last three years. These include cases where vehicles enter the road works or breach rolling roadblocks.
