## **Regional Reports**:

## Scotland Report from Ainsleigh Brown (Transport Scotland)



The Roadworks Reform consultation identified seven essential asset attributes for recording, with ongoing input shaping Vault Part 2 regulations. The policy team is prioritizing a review of prescribed qualifications. The Diversionary Works Code is being redrafted with Scottish collaboration. Transport Scotland released the fourth National Transport Strategy delivery plan and evaluation report. These developments aim to enhance coordination, safety, and efficiency in roadworks and infrastructure management across the UK and Scotland.

### Wales Report from Ben Beachell



The Network occupancy initiative is at the procurement stage, so still a work in progress but we hope to have it in by this time next year. Wales support the Training & Accreditation, diversionary works and safety code reviews.



### Northern Ireland Report from Nile Smith (NI Infrastructure)

Following the NI Assembly's restoration, the 2024–2027 Programme for Government was launched, prioritizing economic growth, childcare, healthcare, housing, safety, and environmental protection. Dfl continues quarterly NIRAUC, SWAG, and DRAUC meetings to coordinate street works. Performance is monitored via NISRANS data and coring. Dfl is addressing the December 2024 NIAO report recommendations and remains engaged with the Geospatial Commission on underground asset data sharing amid renewed UK Government discussions.

### **England Report from Ian Law**



The lane rental forum is to be co-chaired by Sarah Widdows (special adviser to JAG) and Jane James is taking over as the Vice Chair of HAUC England from the authority side to work alongside Nigel Myers (utility Vice Chair for HAUC England). Kevin Ferguson is taking over as Vice Chair of JAG(UK). Lane rental funding - looking to create a template for pot-hole registration. How do we capture this and how are we funding the repairs? The co-ordination code appendix is still on hold pending Sally Kendall and Anthony Ferguson retiring. New S50 regs are expected to become

operational in Jan 2026 and we have the new S74 and FPN charges coming into play. Working through a combined authority lane rental scheme for London which will be aligned with the new bill and approval scheme.

# HAUC(UK) Convention 2025

The 2025 HAUC(UK) Convention took place on April 2nd in Manchester at the Emirates, featuring the theme "Innovation: From Vision to Reality." This event was the largest in its history, attracting nearly 450 delegates and showcasing a bustling exhibition hall.

The day started on a positive note with fine weather, creating an electric atmosphere in the presentation areas and exhibition space. Clive Bairsto, Joint Chair of HAUC(UK) and CEO of SWUK, officially opened the convention to a full audience. Attendees enjoyed a video message from Lilian Greenwood MP, followed by a keynote address from Professor Chris Rogers of the University of Birmingham.

The agenda included presentations on several key topics, such as the new HAUC Vision 2030, the National Underground Asset Register (NUAR), safe planning practices, lane rental, communications, and performance metrics. After a hot lunch, the afternoon featured contributions from representatives of the devolved nations, focusing on data integration and updates from the Department for Transport (DFT).

The convention concluded with farewell remarks from Sally Kendall and Anthony Ferguson, followed by a Q&A session and a summary from Sam Guiver, Joint Chair of HAUC(UK) and Chair of JAG(UK). A prize draw winner was announced, and attendees relaxed on the mezzanine with refreshments before heading home.

Special thanks were given to Gayle Gander and her team at Geoplace for their outstanding planning and organisation, as well as to the convention committee for creating a memorable event, a highlight of the street works calendar. Despite the cold and physical strain, they reached significant milestones but had to halt near Basildon due to Gary's hamstring injury after 40 miles.
